

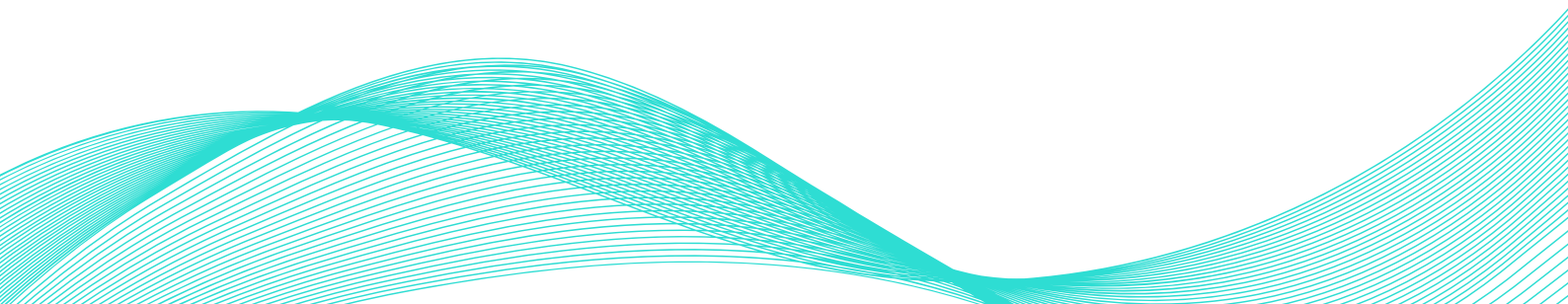

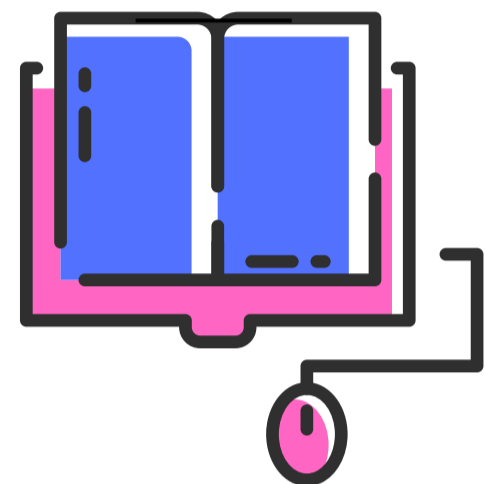
Her father told her to calm ●

Dear Sir:

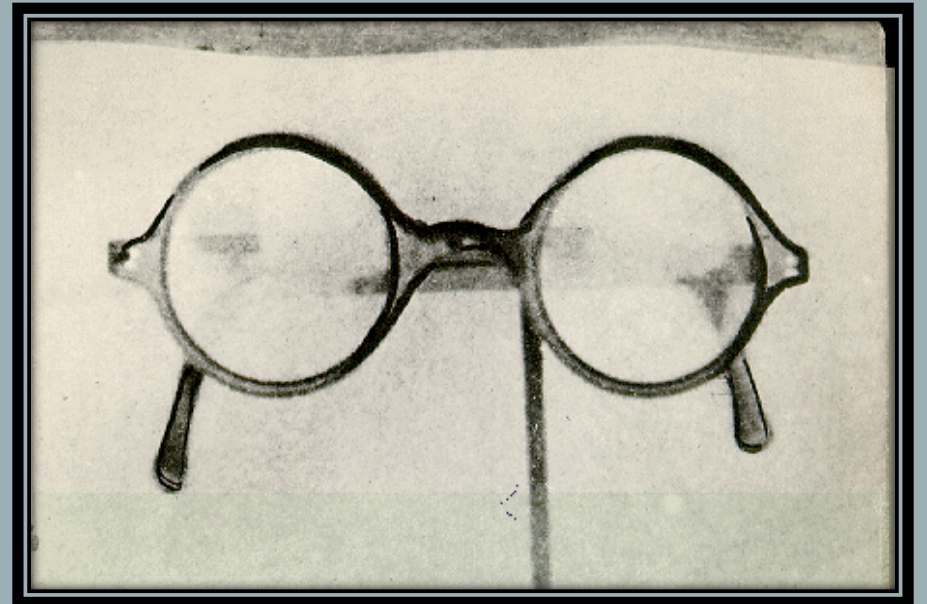



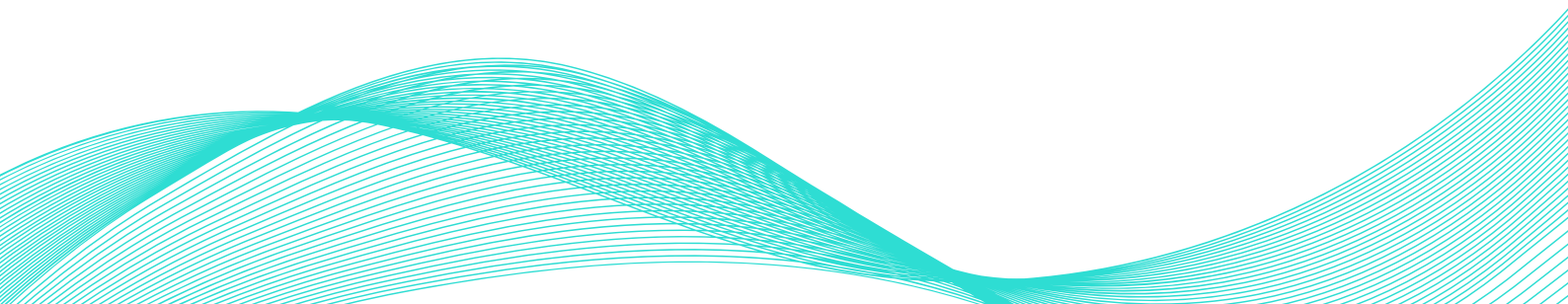
